This Fact Sheet summarizes data from the U.S. Census Bureau Small Area Health Insurance Estimates (SAHIE) on the number and rate of uninsured non-elderly adults in Mississippi by county for 2014 and 2017 for two income categories. From 2014 to 2017, the number of uninsured adults declined in all counties for both income groups.




